COURSE DESCRIPTION:

LIS 5603 introduces reference/information work using print and online sources; the course also explores current trends, professional topics, and issues relevant to information-providing agencies in traditional and online environments.

COURSE OBJECTIVES:

At the end of the course, the student will be able to:

1. Describe the ethical tenets of professional reference services.
2. Apply reference interview strategies to identify the information needs of patrons.
3. Identify which type of reference resources are best to use for answering different kinds of information requests.
4. Combine search strategies to effectively retrieve information from databases.
5. Explain the issues that influence and shape reference services in the electronic age.
6. Assemble a subject list combining appropriate resources for a selected audience and topic.

COURSE ASSIGNMENTS AND EVALUATION:

Reference Department Visit: Visit the reference department/area in a library. The objective of this assignment is for you to observe and evaluate the information services they offer. (100 points)

Reference Interview Practice: You will participate in three reference interview activities, including, but not limited to, interviewing people face to face and online. Then write an essay reflecting on your experiences and insights on your skills as an interviewer. (200 points)

Question Set: You will research and answer sets of reference questions that will give you practice in using the various reference tools discussed in class and in readings. You will search for the same answers using printed and online resources, and write a short reflection on your experience and what you learned from the process. (200 points)

Scavenger Hunt (real user questions): Seek the answers to four real user questions using FSU databases. The report must include choice and combination of search terms, list of databases used, citation of articles to recommend, and the actual answers. Include a short reflective report on what worked, what not, and what you learned from the activity. (200 points)

Special Topic Presentations (Groups): Small student group will prepare a 20-25-minute presentation on the assigned topic based on recommended readings and the group's own research. Student grades will be calculated in part by the group's peer evaluation of participation. (150 points for presentation + 50 points for peer evaluations).

Research Guide (Resource Guide): Your final project for the course will be a research guide intended to be a useful addition to an institution's informational guides (often you'll hear these referred to as "LibGuides.") You will choose a setting, and create a guide that provides an introduction to a wide range of useful reference sources for someone who is interested in doing research on this topic. You will also include a brief evaluation of the institution/setting for which you are creating your guide, its already existing collections and research guides, and how your project fits in and meets a need. (100 points)
